	To repair Ladies Toilet	To overcome the leakage problem in the Ladies toilet it was decided to undertake the repairing work on an urgent basis.
	To improve water cooler facility	It was decided to fit a water cooler on a fixed platform for convenience and to carry out the necessary maintenance work.






