Needy and deserving students are granted Scholarships, Freeships and other educational concessions under the scheme of Government of Maharashtra & Government of India. Details of each scheme are available from the College Office and mahadbt portal.

Government of India Post SSC Freeship/scholarship for reserve category students

Important instructions:

1. Reserve category students are informed that it is mandatory to submit at the time of admission duly filled in Freeship/Scholarship Application Forms along with the necessary documents to avail the benefit of Freeship/Scholarship.
2. They are advised to refer to notices pertaining to Freeship / Scholarship displayed 2. the Notice Board from time to time.
3. As Family's Gross Annual Income Certificate issued by Tahasildar is an important document required for sanction of Scholarship/ Freeship students are advised to immediately commence the procedure to procure the same
4. They are informed that if they fail to submit duly filled in Application Forms along with the necessary documents, they will be treated as open category students for all the purposes and will be required to pay Full Fees.
5. Eligible Reserve Category students will be exempted from paying Full Fees prescribed by the University of Mumbai. The Proposal will be sent to the Social Welfare Department, Government of Maharashtra for its sanction. They will be required to pay the fees not sanctioned by the Social Welfare Department.

Requirement for Government of India post Mastic Scholarships:

Students belonging to SC, ST category and whose Family's Gross Annual Income is LESS than Rs. 2,50,000/- are eligible to apply for the SCHOLARSHIP. Students will be required to submit a Gross Annual Income Certificate issued by Tahasildar.

Students belonging to SC, ST category and whose Family's Gross Annual Income is MORE than Rs. 2,50,000/- are eligible to apply for the

FREESHIP. Students will be required to submit a Gross Annual Income Certificate issued by Tahasildar

Students belonging to OBC, VJNT & SBC category and whose Family's Gross Annual Income is LESS than Rs.1,50,000/- are eligible to apply for the SCHOLARSHIP. Students will be required to submit a Gross Annual Income Certificate issued by Tahasildar.

Students belonging to OBC, VJNT & SBC category and whose Family's Gross Annual Income is MORE than Rs.1,50,000/- are eligible to apply for the FREESHIP. Students will be required to submit a Gross Annual Income Certificate issued by Tahasildar.

Otherwise if the annual income is more than eight lakhs (above 8 Lakhs, such students are NOT eligible for the above freeship.

To avail of the Scholarship/Freeship student must enclose documents along with duly filled in application form for scholarship / freeship as per the scheduled displayed on the notice board.

Students should submit the following documents along with the application form.

1. Attested copy of the caste certificate in the name of the student issued by the competent authority of Government of Maharashtra.
2. Students belonging to OBC, VJ-NT & SBC Category will be required to submit an attested copy of Non Creamy Layer issued by the Tahasildar.
3. Score card and allotment letter.
4. Domicile Certificate.
5. Attested photocopies of certificates of educational qualification (mark sheet) of the previous examination passed.

6. For employed parents, Attested copy of parents Gross Annual Income Certificate i.e., Form No. 16 Certificate under Section 203 of the Income Tax Act, 1961 issued by the employer for the preceding financial year i.e., 1st April to 31st March of the previous year.
7. For self employed parents, Attested copy of parents Annual Income Certificate should be on Self-Certification basis by way of an affidavit on non-judicial stamp paper of Rs. 50.
8. Attested photocopy of First and Last page of Ration Card as proof of permanent residence.
9. Attested photocopy of Date of Birth Certificate.
10. Attested photocopy of College Annual Fee Receipt
11. Attested photocopy of Adhar Card.
12. Affixation of passport size photograph with signature on the Application form.
13. If a student is residing in a Hostel, he / she should attach a Certificate from the Warden of the Hostel along with Lodging and Boarding charges.
14. Details of the Saving Bank Account viz., Name of the Bank, Branch, Address and Account number and nine digit MICR code number of the Bank.
15. Minority Community declaration-affidavit on non-judicial stamp paper of Rs. 50/- by the student that he / she belongs to any one of the Minority Communities notified by Central Government.
16. Any other document required by the competent authority.
17. If a student has a gap between two academic years, he/she will be required to submit court affidavit explaining the reason for the gap period.

Note: Very Important:- It is mandatory for students to have their own bank or post office account. It is also mandatory to link the account number with Aadhar number and Mobile number.

Note: The institution shall have a lien on the documents including marksheet, IF there is a delay/denial of funds under the concerned scheme for any reasons, till the unpaid Fees is not cleared.
